**A) Project Information**

Abhivyakti Media for Development is registered under Foreign Contribution (Regulation) Act 2010 vide registration number 083900052 Date 01-11-2016 During the year Abhivyakti has received conditional grant from as follows :-
1) American Jewish World Service, USA As per agreement dated 29th October 2018 for the purpose of Strengthening Capacities of Young Marginalised Girls and Women in Rural Nashik for the project period 01st December 2018 to 31st May 2020. This grant is received as per Foreign Contribution (Regulation ) Act, 2010. This project has been extended further till 30th November 2020.
2) Ford Foundation, USA , As per agreement dated 17th March 2017 for the purpose of Facilitating Media for Strengthening Expressions in Local Governance in the cities Nashik and Dhule in the state of Maharashtra for the project period 01st April 2017 to 31st March 2020. This grant is received as per Foreign Contribution (Regulation ) Act, This project has been extended further till 30th Sept 2020.
3) Asia South Pacific Association for Basic Adult Education, Philippines. As per agreement dated 04th April 2017 for the purpose of Regional Networking for Transformative Education and Lifelong Learning for the project period 01st April 2017 to 31st March 2020. This grant is received as per Foreign Contribution (Regulation ) Act, This project has been extended further till 31st December 2020.
4) American Jewish World Service, USA As per agreement dated 29th October 2020 for the purpose of Strengthening Capacities of Marginalized Girls in Rural Maharashtra for the project period 01st December 2020 to 30th November 2022. This grant is received as per Foreign Contribution (Regulation ) Act, 2010.
4) American Jewish World Service, USA As per agreement dated 06th April 2020 for the purpose of Empowering Rural Girls in Nashik to Advocate for Their Rights for the project period 01st April 2020 to 31st March 2021. This grant is received as per Foreign Contribution (Regulation ) Act, 2010. This project has been extended further till 30th June 2021.

**B) Significant Accounting Policies**

**1 Basis for preparation of financial statements**

The financial statements are prepared on an accrual basis under historical cost convention.

**2 Revenue Grant**

Grants related with revenue has been recognised on a systematic basis in the Income and Expenditure Account over the period necessary to match them with the related costs as they are intended to compensate. Interest earned on unutilised grant has been credited to grant in advance accounts.

**3 Capital Grant**

Grant received towards acquisition of the assets are recognised as capital expenditure in Fixed assets account and credited to Equipment fund account to match with fixed asset account.

**4 Foreign Currency Transactions**

Grants received in foreign currency have been converted into Indian Rupees at the exchange rate prevailing on the date of receipt. Surplus received on exchange rate fluctuations has been recognised as surplus grant received in advance and such amounts have been utilised in accordance with the terms and conditions of implementation of the project and as per the instructions received from the respective funding agencies. Balance surplus has been included in Grant in Advance and disclosed separately.

**5 Retirement Benefits to Employee**

- a) Group Gratuity cum Life Insurance Policy has been taken from the Life Insurance Corporation of India for the benefit of employees. Gratuity is provided on the basis of valuation determined by LIC. Premium & contribution paid on above policy has been charged proportionately to respective projects.
- b) Contribution to Provident Fund are deposited with Provident Fund Commissioner's Office.


